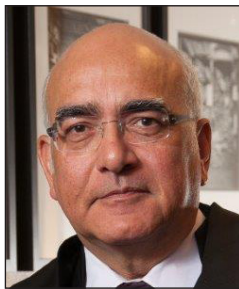


PRESENTERS
