Melissa Poole, Deputy Chair Immigration and Protection Tribunal, Auckland

Melissa was appointed to the Residence Review Board in 1999 and to the Removal Review Authority in 2004. She was appointed Deputy Chair of both tribunals in 2006. Melissa was formerly a senior lecturer in law at the Faculty of Law, Victoria University of Wellington, teaching and researching in public law, administrative law and international law. She is in charge of the residence and deportation (non-resident) jurisdictions.

In 2008, he was appointed Deputy Presiding Member of the Deportation Review Tribunal, and held all four refugee and immigration warrants until the creation of the Immigration and Protection Tribunal in November 2010, when he was appointed a Deputy Chair of the Tribunal. Martin is in charge of its refugee/protection and deportation (resident) jurisdictions.
